(both of which are hereinafter referred to as the “Parties”),

Statement

The Parties concur that they have concluded the Agreement on congestion management on bidding zone border Serbia-Croatia, signed by EMS on 13th December 2017, under no: 503-00-UGO-82/2017-004, and by HOPS on 22nd December 2017, Amendment to this Agreement on congestion management on bidding zone border Serbia-Croatia, signed by EMS on 25th December 2018, under no: 503-00-UGO-58/201-006, and by HOPS on 12th December 2018 and Amendment 1 to Agreement on congestion management on bidding zone border Serbia-Croatia, signed by EMS on 10th December 2019, under no: 503-00-UGO-35/2019-007, and by HOPS for the purpose of organizing transparent allocation of the available transmission capacities at the bidding zone border Croatia – Serbia and assignment of Physical Transmission Rights to the market participants in a transparent and non-discriminatory manner (hereinafter: Agreement). The Parties agree, in accordance with Article XX of the Agreement, to approach the conclusion of this Amendment 2.

Article 1.

By this Amendment 2 Parties agree to replace entirely the existing Annex ./3 Rules for the Allocation of the Cross Zonal Intraday Capacity between the Bidding Zones of Croatian Transmission System Operator Ltd. ("HOPS") and EMS AD Beograd ("EMS") that constitutes the integral part of the Agreement, by new Annex ./3.1 Rules for the Allocation of the Cross Zonal Intraday Capacity between the Bidding Zones of Croatian Transmission System Operator Ltd. ("HOPS") and EMS AD Beograd ("EMS")", that is attached to this Amendment 2 and which constitutes its integral part.

Article 2.

All provisions of the Agreement, unless they are not contrary to the provisions of this Amendment 2, remain unchanged and in force.

Article 3.

This Amendment 2 shall enter into force on the day of the signing by both Parties. On the day of signing of this Amendment 2, Annex ./3.1 Rules for the Allocation of the Cross Zonal Intraday Capacity between the Bidding Zones of Croatian Transmission System Operator Ltd. ("HOPS") and EMS AD Beograd ("EMS") , that is attached to this Amendment 2 shall become the integral part of the Agreement, and shall be applied for the purpose of capacity allocation starting from 1st January 2021. onwards.
